Addressing Behavioral Health

Address the management and treatment of patients experiencing mental health crises in the emergency department (ED) setting through the **Behavioral Health Clinical Learning Collaborative** which supports hospital emergency department and Community Mental Health Center staff in the immediate evaluation, management and treatment of patients with behavioral health emergencies.

Fostering Collaboration for Integrated Disaster Response

Launched in early 2018, the **Granite State Health Care Coalition** (**GSHCC**) is a statewide coalition that supports emergency preparedness planning, response and recovery from events impact the health care system in New Hampshire like the COIVD-19 pandemic.

Collaborating on Hospital Community Investment Reporting

Work with the **23 non-profit hospitals and health systems** to help promote hospital community investment activities, catalyze community health improvement efforts by sharing best practices, and create greater alignment of community health needs assessments.

Assisting with Health Insurance Navigation

Provide free health insurance education and navigation services to New Hampshire residents who need to apply for and enroll in health insurance through Medicaid, the Children's Health Insurance Program (CHIP) or the Health Insurance Marketplace.

Informing Health Care Decisions

Serve as the leading resource for advance care directives and end of life care planning, including POLST, for patients and their families, medical providers, hospitals and health systems statewide, publishing recognized forms for use statewide and providing training and education in best practices through its *Advance Care Planning & Provider Orders for Life Sustaining Treatment (POLST) Facilitator Training* programs.

Inspiring Patient & Family Engagement

Support all **26 hospitals** in their efforts to create a culture of **Patient and Family Engagement** and establish patient and family advisory councils (PFACs) that enhance the delivery of patient and family-centered care throughout the continuum and improve the quality of care delivered as well as the patient experience.

Improving Patient Safety & Quality of Care

Support NH and VT healthcare delivery systems in implementing and designing initiatives that are person-centered and integrated across the healthcare continuum for Medicare beneficiaries, with a focus on rural and critical access hospitals through the **Eastern US Quality Improvement Collaborative.**

Facilitate the **NH Health Care Quality & Safety Commission** to review and analyze quality of care and patient safety issues and sharing best practices known to reduce patient harm for improved health outcomes throughout the state.

Strengthening Rural Health Care Delivery Systems

Convene New Hampshire's **13 Critical Access Hospitals** under the **Rural Health Quality Improvement Network** to provide a broad array of resources that enhance the sharing of best practices for regulatory compliance, quality improvement and patient experience specific to rural health and the state's most vulnerable communities.

Enhancing Access to Substance Use Disorder Treatment

Improve access to addiction treatment for people with **Substance Use Disorders (SUD)** by establishing Emergency Department Bridge to Treatment and Medication Assisted Treatment (MAT) programs for emergency department, primary care and hospital inpatient populations while engaging people living with, or who are in recovery from, a substance use disorder in identifying and testing solution and engagement strategies.

Advancing Total Population Health

Work with partners to foster **healthy, equitable populations** through linking clinical and community-based approaches that improve the health and well-being of NH residents by fostering connections between health care, public health, and the social determinants of health while advancing health equity.

The COVID-19 pandemic has upended our society and economy, challenged our health care systems like never before, and changed the lives of far too many people here in New Hampshire, throughout the country, and around the globe.

The pandemic resulted in an unprecedented response effort by hospitals, health care, public health, EMS, and emergency management, establishing the necessary inter-agency collaboration for an integrated healthcare system response. This collaboration continues to sustain response efforts and preserve partners' and members' ability to maintain essential health care services.

For the last two years, the Foundation for Healthy Communities' Granite State Health Care Coalition (GSHCC), has served as a touchpoint for the health care continuum across the state around priority issues, sharing data and information that informs the state and partners' response to the pandemic, and identifying the challenges and what is needed to support a long-term response and recovery plan.

The turbulence of COVID-19 forced all of us to operate differently as the pandemic delivered a year like no other. 2019 Overview of Hospital Charitable Activities

New Hampshire hospitals go beyond their mission of delivering high quality, affordable health care by collaborating with community partners to collectively address the issues most important to improving the health and well-being of their communities.

With a focus on total population health, hospitals are expanding their community benefit strategies and aligning their charitable investments with broader community health initiatives so that they can better meet the needs of their patients, both inside the hospital and beyond the walls of their institutions.

The **2021 Community Benefit Report** showed that New Hampshire's non-profit community hospitals provided more than **\$577.8 million** in total community benefits, experienced more than **\$282 million** in unreimbursed Medicaid costs and provided more than **\$325 million** in financial assistance to access care in 2019.


