COVID-19 Updates

Ongoing GSHCC Response Actions

The Granite State Health Care Coalition has been involved in a myriad of response activities related to COVID-19 in support of our healthcare partners, members, state and federal partners including:

- Assisting hospitals with required federal and state reporting through Juvare
- Training partners on Juvare implementation
- Supplying federal partners with nightly data reports
- Supplying members with vendor resource lists
- Identifying gaps in reporting and working with healthcare partners on reporting mechanisms to supply active solutions

Mid-Term After-Action Review (AAR) Project

The Granite State Health Care Coalition (GSHCC) recently contracted with the Olson Group to conduct a COVID-19 Mid-Event After Action Report (AAR) process covering the time period of January 2020 through September 2020 in the hopes of capturing not only identified areas for improvement but successes along the way. This report covered up to but does not include the vaccination phase of this response. This AAR process was both eye-opening and informative. The GSHCC solicited input through a survey, interviews, and an after-action meeting. Members and representatives across, healthcare, public health, EMS, emergency management and others across the healthcare and public health sectors jumped in and contributed.

After analyzing the observations, findings, and results there were two documents that were created. The COVID-19 Mid-Event AAR Executive Summary brought together the higher-level findings of successes and areas for improvement in a quick read. The COVID-19 AAR went into further detail of the findings in an attempt to determine root causes and possible mid-course corrections. Both documents are from a statewide coalition lens encompassing the entire healthcare system and may not apply to an individual sector or discipline. Additional AAR phases for COVID-19 are anticipated.

GSHCC COVID-19 Equipment Purchase

The GSHCC was given the opportunity to purchase equipment through COVID-19 funds made available by the Office of the Assistant Secretary for Preparedness and Response (ASPR). This equipment was allocated to the state equipment and supply cache are redistributed to partners in need of these items. Equipment includes electrostatic sprayers, Powered Air-Purifying Respirators/Controlled Air-Purifying Respirators (PAPR/CAPR) units, and tents. The GSHCC sends thanks to the state warehouse and New Hampshire Bureau of EMS for providing logistics for delivering these items to facilities including EMS providers, hospitals, Federally Qualified Health Centers/Community Health Centers (FQHCs/CHCs), Public Health Networks (PHNs) and others.



Immunization Planning Project

Since the fall of 2020, the GSHCC has contracted with Hagerty Consulting, Inc. to support vaccination coordination throughout the healthcare continuum. Through this contract, the Hagerty and GSHCC teams supported vaccination planning and operational coordination in a variety of capacities as needs continued to evolve throughout the response.

In addition to supporting the Granite State Health Care Coalition through ongoing technical assistance, the Hagerty team provided flexible support to the GSHCC team and worked directly with the State of New Hampshire to streamline and refine Just-In-Time mobile clinic training materials that are now available through CDC TRAIN. Hagerty's extensive network of subject matter experts and knowledge of strategies employed in other jurisdictions provided a deeper understanding of the shared challenges of mass vaccinations as well as practical solutions for the future. This insight helped frame the conversations for vaccination operations in New Hampshire.

TTX are generally built for a four-hour timeframe allowing for a scalable and flexible response to a myriad of hazards which include electrical event, telephony denial of service/telephone scam, network outages, winter storm, rain event, infectious disease event, and more to come!

Ongoing GSHCC Activities

GSHCC 2021 Hazard Vulnerability Analysis (HVA) Update

The GSHCC has conducted the annual Hazard Vulnerability Analysis (HVA) with much stakeholder input. This new streamlined process focused on healthcare system mitigation efforts to drive improvement on existing processes as well determine the greatest vulnerabilities to bolster planning, revise training plans, and enhance exercise efficacy. The GSHCC 2021 HVA process was adapted from two similar HVA processes established in New York City and the State of Connecticut. These HVA processes leveraged existing processes to address the unique characteristics of health care coalition partnership. Clinicians and subject matter experts (SMEs) reviewed and provided comments on the plausibility and clinical and/or scientific accuracy of the scenarios.

The GSHCC HVA process was comprised of two phases beginning with a survey sent to GSHCC partners and a 90-minute online seminar in which participants came to a consensus on the rankings of planning priority rankings of the hazard scenarios presented in the online survey and determined mitigation strategies moving forward.

Mitigation Strategies

The representatives participating in the virtual seminar engaged in a discussion around potential mitigation strategies to address the hazard priorities. The top-rated strategies in order are:

- 1. Provide additional trainings of value to all partners.
- 2. Provide additional planning guidance to all partners.
- 3. Strengthen partner engagement in GSHCC exercises.

Next Steps

The GHSCC Leadership Team will be presented with the findings and strategies from this process to help determine implementation steps and future planning priorities.

The final GSHCC HVA report will be disseminated to the entire GSHCC listserv and posted on the GSHCC website upon completion. This statewide HVA may serve as the annual statewide/regional HVA to meet certain CMS requirements.



Pediatric Surge Annex

The Pediatric Surge Annex applies to a coalition-level response to a mass casualty event involving a large number of pediatric patients. This pediatric-focused operational annex serves as an annex to the GSHCC Coordination Plan. It is intended to be a high-level response plan, identifying key resources that exist within the coalition. Infectious Disease Surge Annex

The Infectious Disease Surge Annex is an ASPR requirement that must reflect GSHCC actions relative to a coordinated healthcare surge response to a range of known and emerging infectious diseases. The GSHCC must have the ability to pivot to respond to a myriad of infectious disease agents and severity scenarios. The timing of this deliverable is fitting as COVID-19 presents numerous lessons learned and best practices. This Annex is scheduled for completion by June 2021 and will be disseminated to the entire GSHCC listserv as well as posted the GSHCC webpage.

Ongoing Juvare Trainings

The GSHCC team continues to provide free training in eICS and EMResource to interested healthcare partners on the NH healthcare information management system provided by Juvare. Juvare is open to users from healthcare, public health, and emergency medical services.

The eICS platform is designed to assist organizations in emergency planning, response, and recovery. Users may leverage the system to conduct Hazard Vulnerability Assessments, support emergency notifications, develop and maintain emergency plans, coordinate incident response, and document lessons learned. Facility administrator training for eICS is about two hours.

EMResource is designed to support situational awareness and information sharing between healthcare, public health, and EMS agencies. Facilities may respond to and provide incident-specific information to help inform response. Facility Administrators have added functionality with reports and user management. Training for basic Users and Facility Administrators are available and are one hour.
