## CDC Infection, Prevention, and Control Grant

A total of \$500 million, spread across the entire country, has been made available through the *American Rescue Plan Act of* 2021, P.L. 117-2, is being awarded through the CDC's Epidemiology and Laboratory Capacity (ELC) Cooperative Agreement (CK19-1904). This award is being issued as a program-initiated component called the *'Nursing Home & Long-term Care Facility Strike Team and Infrastructure Project'*.

The Granite State Health Care Coalition has been selected as a recipient of this award in order to assist recipients with supporting long-term care facilities during their response to SARS-CoV-2 infections, and also to build and maintain the infection prevention infrastructure necessary to support resident, visitor, and facility healthcare personnel safety.

Through this funding, the Coalition is setting out on programs and activities in order to enhance infection prevention and control capabilities within nursing and long-term care facilities throughout the State of New Hampshire, through infection prevention education and certification assistance, resources, technical assistance, and infrastructure.

#### Responder, Healthcare, and Public Health Worker Resiliency

#### Continuity of Operations (COOP) Planning Training

#### FEMA EMI- IS- 1300- Introduction to Continuity of Operations

This interactive web-based course is intended to lay the foundation of knowledge for students who wish to increase their understanding of continuity and building a comprehensive continuity program in their organization or jurisdiction.

#### **Public Information Officer (PIO) Training**

#### FEMA EMI- IS-29.A- Public Information Officer Awareness

This course is designed to familiarize participants with the concepts underlying the PIO role. This course can provide a basic understanding of the PIO function for those new to the position. Additionally, it can provide those in executive level roles the necessary knowledge of PIO roles and responsibilities during an emergency.

## COALITION EXERCISE INFORMATION

#### **Radiation Surge Annex TTX**

The Radiation Surge Annex applies to a coalition-level response to a mass casualty event involving a large number of pediatric patients. GSHCC is currently in the process of developing a tabletop exercise to validate the Annex along with key partners and other subject matter experts. This exercise will take place in Spring 2023 and will address pre-hospital response, patient movement, and reunification. Additional information to come.



#### Medical Response & Surge Exercise (MRSE)

GSHCC conducted the Medical Response and Surge Exercise (MRSE) in mid-October. Partners from across the healthcare and public health sectors participated in this operations-based exercise. The exercise was designed to stress the healthcare system in New Hampshire through a sudden surge scenario by testing functional surge capacity and identifying gaps. ## COALITION EXERCISE INFORMATION

#### **Burn Surge Annex TTX AAR/IP Outcomes**

Partners from healthcare, public health, emergency medical services, and emergency management participated in a virtual Burn Surge tabletop exercise in May 2022. Participants were guided through a burn mass casualty incident scenario as a fire occurred at an indoor commencement ceremony with more than 1,000 attendees. The objectives of this exercise were to review existing burn care assets and identify gaps that may occur in a burn mass casualty incident; review agency/facility roles in a burn mass casualty incident; validate assumptions in the NH GSHCC Burn Surge Annex and identify changes that need to be made in the NH GSHCC Burn Surge Annex based on the roles and capabilities of the involved partners. Overall, participants were able to achieve these objectives with some noted challenges.

Participants successfully identified some supporting resources for this type of response however, it is clear New Hampshire lacks adequate burn resources, including a burn center. While hospitals have had years of practice throughout the COVID-19 pandemic responding to surge, burn surge capabilities are much different. Individual capabilities to surge acutely are also limited when considering burn patients. As discussions evolved, it became clear the process for determining burn patient transfer prioritization is a challenge. Statewide patient re-distribution plans need to be developed. It is also evident that hospitals participating in the NH trauma program are more prepared to provide initial stabilizing treatment to burn patients during a burn mass casualty incident than those that are not. It also became clear it is necessary for all to develop a shared understanding and practice for large-scale patient movement, beyond hospital systems and current transfer agreements.

GSHCC has engaged stakeholders to update the *NH GSHCC Burn Surge Annex* with updated information and additional language, where possible. However, additional planning specific to addressing a burn surge incident is required. GSHCC members and partners are encouraged to review the GSHCC Burn Surge Annex Tabletop Exercise After Action Report and Improvement Plan for more information about the exercise. The GSHCC will continue to engage partners in planning efforts related to managing medical surge in additional exercises.

## GSHCC COVID-19 After Action Review #3

The GSHCC is in the process of completing the third iteration of the COVID-19 After Action Review and Improvement Plan (AAR/IP). This process consisted of a survey, partner interviews, and After-Action Meeting, This iteration focused on the end of the State of Emergency through June 30, 2022. This included the Delta and Omicron Surges, Booster Blitz 1 and 2, supply chain shortages, staffing shortages, testing changes, the initial recovery stage and much more.

The final report will be shared upon completion.
