#### CDC Infection, Prevention, and Control Grant

Over nearly the last 2 years, the Granite State Health Care Coalition and the Healthcare Associated Infections Program (HAI) within NH DHHS have been working with Long Term Care (LTC), Assisted Living Facilities (ALF), and Skilled Nursing Facilities (SNF) on infection prevention and control capacity building through the Centers for Disease Control and Prevention (CDC), CDC's, *Strike Award*. With the program scheduled to conclude on May 11, 2024, the GSHCC would like to take a look back at all that was accomplished. Through *Strike*, the GSHCC and HAI conducted workshops throughout the state aimed at N95 Fit testing and GloGerm hand hygiene train-the-trainer workshops. At the time of composition of this publication, over the course of 16 workshops, more than 172 individuals from over 94 facilities across New Hampshire have been trained, provided equipment for use at their facilities, and educated on additional infection prevention resources such as Infection Control Assessment and Response (ICAR) tools for use in infection prevention and control assessments and audits.

Throughout the course of the *Strike Award*, the GSHCC has worked closely with NH Needs Caregivers to increase the amount of Licensed Nursing Assistants, LNAs, in the workforce, find employment, and offer assistance for those seeking infection prevention and control certifications. At the time of composition of this publication, 112 individuals have been licensed as an LNA, and 68 have found employment (25 SNF, 43 LTC). 5 individuals have obtained their Long-Term Care-Certification in Infection Prevention (3 SNF, 2 LTC). Another 31 individuals have their ServSafe Food Protection Manager Certification (25 SNF, 6 LTC). From March 12-14, 10 participants across SNF and LTC facilities completed the Certificate in Non-Acute Care Cleaning Program (CNACC).

While *Strike* may be coming to a close, GSHCC's commitment to partners by providing assistance, guidance, and support will not. The GSHCC will continue to provide resources and assistance whenever possible.



The Emergency Management Institute (EMI) has a free online course to provide knowledge to participants on continuity planning. The course objectives include defining the importance of continuity planning for organizations and communities, description of key elements of a continuity program, and the whole community approach to continuity planning.

#### **Public Information Officer (PIO) Training**

This course is designed to familiarize participants with the concepts underlying the PIO role. This course can provide a basic understanding of the PIO function for those new to the position. Additionally, it can provide those in executive level roles the necessary knowledge of PIO roles and responsibilities during an emergency.

#### **E0105: Public Information Basics**

The Emergency Management Institute (EMI) has an in-person three-day course that provide participants with basic skills of communications, understanding and working with the media and techniques to perform effectively as a PIO in times of an emergency response.

#### COALITION EXERCISE INFORMATION

#### 2023 GSHCC MRSE

The GSHCC team and core partners conducted the MRSE annual exercise on December 6, 2023. Core participants included hospitals, NH DHHS, DPHS, Bureau of Emergency Preparedness, Response, and Recovery (EPRR), Regional Public Health Networks (RPHNs), Skilled Nursing Facilities (SNFs), Home Health Care, Long Term Care (LTC), Department of Safety (DOS), and NH HSEM.

The exercise scenario tested three acute care hospitals, (Portsmouth Regional Hospital, Exeter Hospital, and Southern New Hampshire Medical Center). The scenario presented two hospitals with pipe bursts and water damage and the other hospital with an external and internal gas leak. Each of the three hospitals simulated an evacuation.

Other hospitals participated in the scenario where they were presented with mass casualty patients from a fire or a motor vehicle accident. The RPHNs were tasked to set up shelters for the community members in their region due to the weather conditions in the scenario. Also, the scenario presented with power outages at a LTC facility.

#### **Lessons Learned**

- Development of a Medical Operations Coordination Center (MOCC) to support healthcare agencies with patient/resident load-balancing during an emergency incident.
- Implement LTC, SNF, Home Health, and VNAs in hospital surge events requiring patient movement and/or evacuation.
- Utilize Juvare EMResource in patient tracking for a medical surge event.


#### COALITION EXERCISE INFORMATION

#### **Chemical Emergency Surge Tabletop Exercise (TTX)**

The Chemical Emergency Surge Annex is a new annex that is currently under development. The annex will address risks for community chemical events, coordination of decontamination of patients in the hospital and EMS settings, mobilization of chemical countermeasures (including CHEMPACK), reception center plans with public health partners, and the involvement and coordination of regional HAZMAT resources.

The Chemical Emergency Surge Tabletop Exercise will be conducted on May 1, 2024. The GSHCC will partner with core members and subject matter experts to develop the exercise. The exercise will test a sudden surge of patients that require chemical countermeasures, reception center plans, HAZMAT resources and simulated patient movement.

#### **ASPR TRACIE**

The U.S. Department of Health and Human Services (HHS) Administration for Strategic Preparedness and Response (ASPR) Technical Resources, Assistance Center, and Information Exchange (TRACIE), has a technical resource reference page with lessons learned, templates and after-action reports (AAR) to utilize for your planning and exercise conduct needs. These templates encompass an all-hazards approach for health care needs with scenarios including but not limited to, active threat, cybersecurity, severe weather, utility failure, patient surge events and public health emergencies.



#### **ASPR TRACIE**

#### **Tabletop Exercise Templates**

The GSHCC has created an array of discussion-based tabletop exercise templates for use at your facility. These templates may assist facilities looking to meet annual exercise requirements per regulatory authorities. Discussion-based exercises are built for a four-hour timeframe allowing for a scalable and flexible response to a myriad of hazards which include electrical event, telephony denial of service/telephone scam, network outages, winter storm, rain event, infectious disease event and others! Each template follows the Homeland Security Exercise and Evaluation Program (HSEEP) guidelines. 

NH Crisis Standards of Care: The Road Ahead

During a major or catastrophic public health incident that results in medical surge, each health care facility or health care system would activate their surge response plan to determine the most appropriate steps and actions for their entity base on their environment, hazards, and resources. Pre-event health care emergency management planning and training is highly recommended to diminish the likelihood of impromptu decisions.

The NH Division of Public Health Services (DPHS), Bureau of Emergency Preparedness, Response, and Recovery (EPRR) invited hospital Chief Medical and Nursing Officers, hospital emergency management coordinators, clinical and administrative hospital incident management teams to a virtual presentation by John Hick, M.D. on core concepts of Crisis Standards of Care (CSC) in health care and public health emergencies and the importance of clinical input during both planning and response to situations that place our State's health care system in crisis.



John L Hick, MD

Dr. Hick is an emergency physician at Hennepin Healthcare in Minneapolis, MN and initiated a State clinical advisory team for the MN Department of Health that was formally chartered in 2006. The MN clinical advisory team played an integral role in planning and responding to a variety of scarce resource situations, most notably during the COVID-19 pandemic. Dr. Hick wrote the initial articles on ventilator triage and CSC definitions and is an international expert on CSC.

The objectives for this recorded presentation were:

- Discuss the role and importance of CSC in equitably responding to health care and public health emergencies.
- Introduce the roles, responsibilities, and structures that support health care organization decision-making in the context of limited resource availability.
- Explore and gather feedback regarding the potential implementation and applications of these concepts and structures for New Hampshire.

Dr. Hick presented a roadmap of key domains and requirements in crisis standards of care for healthcare providers, healthcare facilities/systems, and coalition/state partners. He encouraged hospitals to integrate crisis space and staffing plans into their hospital surge plans. Collaboration is needed between hospitals, coalitions, and state partners regarding resource allocations and loadbalancing mechanisms. Suggested state priorities include state actions to support surge strategies and decision-making and the need for care in place support — including legal protections.

The medical surge-related corrective actions identified in the After-Action Report of the EPRR 2023 Wicked Catastrophe: Medical Surge Meeting Mass Fatality virtual tabletop exercise are being addressed through Dr. Hick's presentation, and his facilitation of the upcoming in-person CSC workshop/tabletop. In addition, these sessions further support EPRRs continued work on State-supported medical surge response.

The May 29, 2024, CSC Workshop/Tabletop event registration is for hospital Chief Medical and Nursing Officers, hospital emergency management coordinators, legal counsel, and administrative and clinical hospital incident management teams. Information and registration will be sent within the next couple of weeks.

Anyone in NH is eligible to purchase AEDs at a discount rate of 30-50, depending on the AED model, through the Bureau of EMS- Division of Fire Standards and Training & EMS.
