NH GSHCC Readiness Assessment and Plan

The GSHCC is working on compiling a Readiness Assessment and Plan. The Readiness Assessment will consist of a survey and gap analysis to determine the GSHCC's capacity and capability to conduct Hospital Preparedness Program (HPP) activities for 2024-2028. Findings from the gap analysis will inform the Readiness Plan. The Readiness Plan will include a Training and Exercise Plan that will include training opportunities, tools, and resources that apply to the healthcare workforce on topics relevant to NH.




2024-2025 GSHCC Hazard Vulnerability Analysis (HVA)

The GSHCC HVA is an annual deliverable conducted to inform GSHCC planning priorities, identify gaps, and enhance training and exercise planning. A survey was disseminated to over 1000 partners to assist the GSHCC team in identifying mitigation strategies as well as priority actions to build and sustain preparedness, response, and recovery capabilities across the state. The GSHCC completed its HVA Meeting on September 5th with more than sixty partners across the healthcare continuum in attendance. Partners reviewed the results of the HVA survey and discussed further developing mitigation strategies. The results of both the survey and meeting will be incorporated into a final HVA Report and shared with GSHCC membership by the January 31, 2025 due date.

HPP PLANNING ACTIVITIES & PROGRAM OUTLOOK

GSHCC Long-Term Care and Skilled Nursing Facility Emergency Operations Plan (EOP) Program

A robust emergency preparedness program is critical for facilities in preparing for, responding to, and recovering from a multitude of disasters and incidents. The GSHCC has developed organizational and instructional resources for Long-Term Care and Skilled Nursing facilities aimed at assisting in the development of facility emergency preparedness programs and emergency operations plans relative to federal and state emergency preparedness requirements.

The Healthcare Cyber Threat Landscape: Risk, Impact, and Preparedness

John Riggi- National Advisor for Cybersecurity and Risk, American Hospital Association

Join John Riggi, National Advisor for Cybersecurity and Risk for the American Hospital Association and former FBI Cyber senior executive, as he provides his unique national and international perspective on the latest cyber threats including those arising from geopolitical tensions, third-party providers, and supply chain disruptions. John will discuss how best to prepare for, respond to, and recover from these disruptive cyber-attacks as well as the regional impact. He will discuss the rise he's seen in incidents of bad actors going after third-parties as well as effective risk management strategies. He will also provide his insights on the latest cyber legislative and policy developments. As John always says, "This presentation is designed not to scare, but make aware, so we can prepare."

Lessons Learned from the Liberty Hospital Ransomware Attack

Carolyn Wells of Liberty Hospital in Kansas City, Missouri will present on lessons learned from their recent ransomware attack and subsequent extended downtime event.

When Everything Changes in A Minute: Lessons Learned from the 2023 New Hampshire Hospital Shooting

Allen Coen- Director of Facilities, New Hampshire Hospital

Allen will discuss high level lessons learned from the November 2023 New Hampshire Hospital active shooter event and provide an update on how the hospital is recovering nearly one year post-incident. Allen will also touch on best practices, mitigation measures, planning considerations, and how these lessons learned have changed their original planning assumptions and some steps they have implemented thereafter.

TRAINING INFORMATION

Continuity of Operations (COOP) Planning Training

FEMA EMI- IS-1300- Introduction to Continuity of Operations

The Emergency Management Institute (EMI) has a free online course to provide knowledge to participants on continuity planning. The course objectives include defining the importance of continuity planning for organizations and communities, description of key elements of a continuity program, and the whole community approach to continuity planning.

Public Information Officer (PIO) Training

FEMA EMI- IS-29.A - Public Information Officer Awareness

This course is designed to familiarize participants with the concepts underlying the PIO role. This course can provide a basic understanding of the PIO function for those new to the position. Additionally, it can provide those in executive level roles with the necessary knowledge of PIO roles and responsibilities during an emergency.

E0105: Public Information Basics

The Emergency Management Institute (EMI) has an in-person three-day course that provides participants with basic skills of communications, understanding and working with the media and techniques to perform effectively as a PIO in times of an emergency response.

TRAINING OPPORTUNITIES

NEW Hospital Incident Command System (HICS)

GSHCC has developed a Hospital Incident Command System (HICS) training for hospital leaders. HICS was created by California Emergency Medical Services with Kaiser Permanente to assist hospitals in responding to emergency incidents. This training will review the scope and objectives of the HICS model of incident command operations including HICS materials (Incident Action Plan, Job Action Sheets, etc.). The course will also provide a hands-on activity to practice the HICS concepts. The course is recommended for hospital leadership and staff that would fulfill the roles of Incident Command. NEW How to Conduct a Tabletop Exercise

GSHCC has developed a training on how to conduct a tabletop exercise for healthcare. A tabletop exercise is one of the many forms of exercising emergency preparedness plans at healthcare facilities. This training will provide partners with hands-on training and materials on how to successfully plan, facilitate, and document the tabletop exercise. We recommend this training for all partners who are new to tabletop exercise concepts or partners who need to review concepts on conducting a tabletop exercise. NEW - OPENING SOON!

Hospital Emergency Management Coordinator (HEMC) Orientation

The GSHCC is developing a Hospital Emergency Management Coordinator (HEMC) Orientation program for new HEMCs. This program will be a full day and in person course to welcome new HEMCs into their role and provide an overview of GSHCC and state resources. The training will provide the HEMCs with an overview of Juvare EMResource and eICS. HEMCs will also be introduced to the NH DHHS, DPHS, Bureau of Emergency Preparedness, Response, and Recovery (EPRR). The program will become available by the end of Fall 2024. COALITION EXERCISE INFORMATION

2024-2025 GSHCC Medical Response & Surge Exercise (MRSE)

The GSHCC team and core partners will conduct the annual exercise in March 2025. Core participants include hospitals, NH DHHS, DPHS, Bureau of Emergency Preparedness, Response, and Recovery (EPRR), Regional Public Health Networks (RPHNs), Skilled Nursing Facilities (SNFs), Home Health Care, Long Term Care (LTC), EMS, and NH HSEM.

The exercise will test medical surge statewide.

Federal Emergency Management Agency (FEMA) has an online portal that provides tools to support exercise design and development and tools to support partners in conducting evaluation and improvement planning. The portal follows all six components of the National Preparedness System (NPS) which ensures exercises meet requirements.

ASPR TRACIE

The U.S. Department of Health and Human Services (HHS) Administration for Strategic Preparedness and Response (ASPR) Technical Resources, Assistance Center, and Information Exchange (TRACIE), has a technical resource reference page with lessons learned, templates and after-action reports (AAR) to utilize for your planning and exercise conduct needs. These templates encompass an all-hazards approach for health care with scenarios including but not limited to, active threat, cybersecurity, severe weather, utility failure, patient surge events, and public health emergencies.



ASPR TRACIE

Tabletop Exercise Templates

The GSHCC has created an array of discussion-based tabletop exercise templates for use at your facility. These templates may assist facilities looking to meet annual exercise requirements per regulatory authorities. Discussion-based exercises are built for a four-hour timeframe allowing for a scalable and flexible response to a myriad of hazards which include an electrical event, telephony denial of service/telephone scam, network outages, winter storm, rain event, infectious disease event and others! Each template follows the FEMA Homeland Security Exercise and Evaluation Program (HSEEP) guidelines.
